

Your special attention is invited to the following rules :

1. No question shall be set at any University Examination which would require an expression of religious belief on the part of the candidates.
2. Candidates shall give their answers in their own words as far as practicable in all subjects. The direction shall be written as a head note in every question-paper. Paper-setters are to write in the margin on the left hand side the Serial No. of questions and on the right hand side against each question the full marks assigned to it. If all the questions carry equal marks, it is to be stated accordingly at the top.
3. Paper-setters shall always allow some choice of questions and also indicate clearly on the top of the question paper how many questions are to be answered in all. The proportion of the questions to be answered to the total number of questions set in each paper should be roughly in the ratio of 6 to 10. Any question intended to be answered as a compulsory one should be prominently indicated in the question paper. The number of alternatives intended to be associated with a particular question should not ordinarily exceed one. Care should be taken to see that the alternatives are of comparable standard.
4. Persons setting papers shall be guided, as to the scope of the subject of examination, by the Syllabus prescribed for the purpose, and as to the standard and extent of knowledge required, by the books if any, recommended from time to time for such purpose.
5. The questions set for an examination will be such as will reasonably conform to the standard expected in respect of that examination and should be fairly and uniformly distributed over the whole course covered by that paper. There should not be any marked change of standard from year to year, but it is not required that the same type of questions should be set every year.
6. Maintaining the standard, the questions should be set in clear and unambiguous language so that the candidates may have no difficulty in appreciating their scope and purpose.
7. Questions should be framed in such a way as to test the student's intelligent grasp of broad principles and his/her power of intelligent presentation in literary subjects. Questions should be set to encourage good methods of work and teaching and discourage unintelligent memorizing and submission of readymade answers found in note-books.
8. Particular care should be taken to ensure that the candidates may have reasonable time to think over and to answer all questions within the allotted time leaving a fair margin for revision work.
9. In the case of subjects which naturally admit of a division into groups or branches, the question should be split up into the required number of groups and the candidates be asked to answer at least one question from each group. This will ensure a candidate's knowledge of the entire course and also give him/her the opportunity of choosing more questions from the group with which he/she may be particularly conversant.
10. No copy of manuscript of the question-paper is to be retained by the paper-setter and all relevant drafts, notes, etc., should be effectively destroyed.
11. The University shall appoint a Moderator or a Board of Moderators in each subject, wherever possible, who will moderate the question-papers in consultation with the Paper-setters, if necessary.
