ORDER

Restoration of Recognition and Change of Premises

WHEREAS, Govt. Physical Education College for Women, Chawkabazar, Po. & Dist.- Hooghly, West Bengal-712103 (APE00651) was granted recognition for B.P.Ed. course with an intake of 50 vide ERC order dated 07.04.2007, followed by revised recognition order issued vide no. 32253 dated 27.05.2015 with an intake of 100 with two sections of 50 each from the academic session 2015-2016 as per NCTE Regulation, 2014.

- 2. AND WHERAS, the ERC in its 271st meeting held on 24th 25th April, 2019 considered the matter and as decided, recognition granted to B.P.Ed. course was withdrawn u/s 17(1) of NCTE Act 1993 from the academic session 2019-2020 vide order No. ER-271.1.26/APE00651/B.P.Ed./2019/60502 dated 21.05.2019 to the institution.
- 3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 21.05.2019. The Appellate Authority vide order No.89-282/E-126003/2019 Appeal/26th Mtg.-2019/26th August, 2019/82274 dated 26.09.2019 remanded back to the ERC with a direction to conduct an inspection of the new premises of the appellant institution and take further action as per the NCTE Regulations, 2014.
- 4. **AND WHEREAS**, the ERC in its 277^{th} meeting held on $19^{th} 20^{th}$ Dec, 2020 considered the appeal order dated 26.09.2019 and as decided, Show Cause Notice u/s 17 was issued on 26.12.2019 on the ground that the institution is directed to submit the appropriate application for shifting of premises along with all necessary documents.
- 5. AND WHEREAS, the institution had submitted reply dated 10.01.2020 along with application for Shifting to its new premises i.e. Govt. Physical Education College for Women, RICE Research Station, Chisurah (RS), Dist.-Hooghly, West Bengal-712102, received in this office on 15.01.2020.
- 6. AND WHEREAS, the ERC it its 283rd meeting held on 24th 25th August 2020 considered the application for shifting of premises and decided that VT to be constituted under section 14 of the NCTE Act, 1993 to ascertain infrastructure and instructional facilities of the TEI for shifting of premises to the new address. Accordingly, inspection was conducted by the VT experts on 1st & 2nd November, 2020.
- 7. AND WHEREAS, the ERC in its 287th meeting held on 14th December 2020 considered the Visiting Team Report and the Committee decided as under:-
 - (i) Restoration of recognition order of B.P.Ed. course with an annual intake of 100 (one unit) be issued.

- 8. NOW, THEREFORE, recognition of the institution viz. Govt. Physical Education College for Women, hawkabazar, Po. & Dist.- Hooghly, West Bengal-712103 (Code No. APE00651), withdrawn vide order no. ER-271.1.26/APE00651/B.P.Ed./2019/60502 dated 21.05.2019, has been restored for conducting B.P.Ed. course of two years duration with an annual intake of 100 (one unit) and permission is granted to the institution to shift its new premises i.e. Govt. Physical Education College for Women, RICE Research Station, Chisurah (RS), Dist.-Hooghly, West Bengal-712102.
- 9. The terms & conditions of the order No. 32253 dated 27.05.2015 issued to the institution shall remain same. ν
